3. All claims and debts against the decedent and against the estate have been fully paid and discharged. The estate is ready for distribution and is now in a condition to be closed.
4. The Administratrix, Carol Ann Telford Butler, waives statutory fees as provided by the statutes of Guam;
5. The estate shall pay probate fees as provided by the statutes of Guam; and
6. The assets of the estate be distributed to Priwan Moontri and Pornchai Moontri, share and share alike.
